## JVCOCC Message

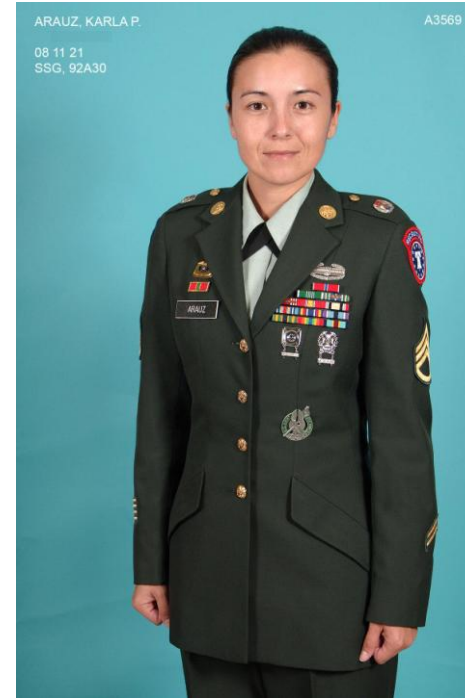

Staff Sergeant Arauz entered the United States Army on 18 August 2000. Her first duty assignment was Fort Hood, Texas.

She deployed to Egypt for Operation Bright Star 2001/02. In September 2004, still assigned to Fort Hood, Texas, she worked as the Battalion S2 and deployed in support of Operation Iraqi Freedom (OIF) II where she earned the Bronze Star for support.

In August 2005, she deployed to Louisiana to provide humanitarian relief in support of Joint Task Force Katrina. In September 2007 she again deployed in support of Operation Iraqi Freedom (OIF) IV performing Security Escort Convoy missions and worked as a squad leader and Assistant Convoy Commander.

In April 2008, she was assigned to the Cleveland Recruiting Battalion and has earned the gold recruiting badge for excellence.

In November 2009, she was named Cleveland Recruiting Battalion Non-Commissioned Officer of the Year.

**Timothy Allen Martin**  
**Specialist (E-4)**

Timothy Martin joined the Army at the age of 17 in February of 2004, just a couple of months after his father's retirement from the Army with 22 years of service and considered following in his footsteps. He was assigned to the 3<sup>rd</sup> Brigade 71<sup>st</sup> Cavalry 10<sup>th</sup> Mountain Division and deployed to Afghanistan in January of 2006. He was wounded in combat on October 29<sup>th</sup> of 2006 from an RPG blast and a ricochet AK-47 bullet, he received a Purple Heart that December and later the Army Commendation Medal with Valor plus others. Initial treatment and recovery was in country and then he rejoined his unit stateside in May of 2007 and shortly thereafter was shipped to a Wounded Transition Unit. He was honorably discharged on June 22, 2008.



Since then Tim has focused on bringing normalcy to his life from the effects of combat. After a couple of years of significant struggles, he has overcome some of the major hurdles. The entry into his life of his fiancé, Dara L. Mize, he considers the pivotal event in achieving the turnaround and her support for continued recovery. Tim is going to pursue a college degree this fall in an area that will allow him to help those who served, are serving and their families.

In the meantime he has been committed to helping his fellow comrades in arms who have and are also struggling with the trauma of combat. He is also helping them in navigating the benefits applications process and encouraging them to seek medical help through the VA. He has made himself available during any hour of the day for those he has an opportunity to help, especially during their times of greatest need. He gains great satisfaction from helping his fellow veterans and those serving and considers it his duty.

# ALBERT M. WHATMOUGH

COMMAND SERGEANT MAJOR  
OHIO NATIONAL GUARD

CSM Albert M. Whatmough enlisted in the Ohio Army National Guard in January 1986. He graduated from Akron St.Vincent-St.Mary High School, and completed his Army Basic Training at Ft. Knox, KY as an Armor Crewman. At the 3rd Squadron, 107th Cavalry he served as tank driver, loader, gunner and tank commander on the M48, M60, M1 and M1A1 series tanks. He was Instructor and Course Manager at the Ohio National Guard State Military

Academy, 145th RTI. At Company D, 1st Battalion 107th Armor, in 1991 was Platoon Sergeant, then became its First Sergeant. He served as 16th Engineer Brigade Operations Sergeant Major for Joint Task Force Chiriqui, Honduras. In 2000, he became Command Sergeant Major of the 1st Battalion, 107th Armor, later reorganized as 145th Combined Arms Battalion (Heavy). CSM Whatmough has had two combat tours in Iraq. First one in 2004, as Command Sergeant Major for 6,800 soldiers, airmen and U.S. Army Contractors on Forward Operating Base Endurance near the city of Mosul and the second one in 2007, as Command Sergeant Major of the 37th Infantry Brigade Combat Team, with an authorized strength of 3,680 soldiers. The 37th IBCT supported operations in Iraq, Kuwait and Afghanistan. In March of 2009 he was selected to serve as the State Command Sergeant Major for Joint Forces Headquarters Ohio, with an end strength of 11,611 soldiers.

CSM Whatmough is a graduate of the Primary Leadership Development Course, Tank Commanders Course, U.S. Army Observer Controller Course, Basic and Advanced Noncommissioned Officer Academy, Battle Staff Course. In 2004, he graduated from the United States Army Sergeants Major Academy. CSM Whatmough holds a bachelor's degree in Management Information Systems from the University of Akron and is enrolled in a Master's of Science Program at Central Michigan University.

Among CSM Whatmough's awards are the Bronze Star Medal, Meritorious Service Medal (1st Oak Leaf Cluster), Army Commendation Medal (2nd Oak Leaf Cluster), Army Achievement Medal (3rd Oak Leaf Cluster) plus many others. CSM Whatmough's decorations include: Order of Saint George (Armor).

CSM Whatmough is married to Diana Whatmough, a U.S. Army Contractor and assistant to the State Director of Family Programs, they reside in Akron, Ohio. They have two children, daughter Tarah who is attending Ohio Dominican University, and a son Jeffery, a junior at Archbishop Hoban High School, in Akron.
