A. Steve Klosowski

Polish Legion of American Veterans

Adolf Steve Klosowski was born on December 20th, 1944 in a labor camp called 'Bad Abling' in the outskirts of Kolbermoor, Germany. With his parents and older sister, Julia, he came to the United States in 1949. Because of World War II, he chose to use his middle name, Steve. Steve and his father became naturalized citizens in 1956.

Steve attended St. John Cantius High School for 3 years, and graduated from Rhodes High School due to financial hardships after his father passed away in 1958. Living at home with his mother, two sisters, and three brothers and working for Ohio Bell Telephone Co. Steve volunteered for the draft and entered the US Army in March of 1965.

Steve's basic training was at Fort Knox, Kentucky, the AIT training at Fort Ord, California and airborne training (jump school) at Fort Benning, Georgia. Steve was assigned to Headquarters Company, 1st Battalion, 505th Airborne Infantry, 82nd Airborne Division at Fort Bragg, North Carolina. In January of 1966, after about three telegrams of order changes, he was at Camp Alpha in Saigon, Vietnam. Steve was then transferred to the 1st Cavalry Division in An Khe, and immediately shipped to the central highlands, north of Pleiku and was assigned to the Service Battery of the 6th Battalion, 14th Artillery, supporting the 1st Cavalry. Steve hauled projo's and powder on five ton trucks into areas of anticipated or active firefights. Steve made rank of Sgt E-5 on December 19th, 1966 and was discharged from the service on January 17th 1967, as an early out. He was awarded Parachutist Badge, plus the Good Conduct, Vietnam Service, Vietnam Campaign, and the National Defense Service medals.

Upon urging by Jim Quisenberry, Steve joined the Vietnam Veterans of America Chapter #15 (VVA15) in 2002 and became an active and untiring member especially supportive of fellow veterans, their families, and veteran related activities and currently serving as Secretary of Minutes. He also became a member of the VFW Post 1974 in Parma, Ohio. Steve is also a member of the 82nd Airborne Association-John Towle Cleveland Chapter. Steve joined the Polish Legion of American Veterans Post 30 (PLAV30) in Tremont where he became 2nd Vice-Commander, and chairing the annual Chili Cook Off.

Steve is a great example of a veteran living a soldier's motto of never abandoning a comrade in arms and remembering that we are comrades for life. With PLAV30 Steve helps out at Wade Park Veterans Hospital, with poppy sales, and as a member of its Honor and Color Guard, he serves at the Western Reserve National Cemetery in Rittman, Ohio and activities such as Polish Constitution Day Parade. As a member of the Color Guard for VVA15, Steve has been a dedicated participant in the End of the Vietnam War Ceremonies on April 30th, remembered each year by both Vietnam Veterans at Mall "A" and by activities in the Vietnamese Community, he helps place flags at veterans' gravesites at Holy Cross Cemetery, and also marches at the Memorial Day and 4th of July Parades in Parma.

Steve chaired a get together of veterans from the Veterans Home in Sandusky, Ohio with the VVA Chapter #15; PLAV Post 30; VFW Post 7572 from Marblehead, Ohio; and 82nd Airborne Association - John Towle Cleveland Chapter. The theme of this get together was called the 'Veterans Appreciation Island Picnic' at Put-n-Bay and was held on Tuesday, August 23rd, 2005. Steve has been a Scoutmaster, helps out with the March of Dimes Walk, he is a member of Alhambra (organization helping mentally handicapped children) and 2006 Grand Commander of its Al Jana Caravan #159 Chapter. He is a member of the Holy Name Society at Corpus Christi Church, and each year for the past 20 years, Steve has been going to the right to life march in Washington D.C.

Steve was married on June 2nd, 1969. Steve and former wife Marilyn are the parents of three grown children: Steven Michael, Jennifer Louise, and Melinda Ann. Steve retired from the Cleveland Electric Illuminating Company in 1993. He was a 'General Lineman' in steel towers transmission Hi-lines doing 'Hot-Stick' (live power) work on 138,000 and 345,000 volt electric lines. He presently works part time with G & N Cadco as a safety man for cellular telephone tower crews that are working on First Energy hi-line towers, or near energized lines. We wish Steve good health so he can continue his commendable work.

Bohdan Samokyszyn
 Ukrainian American Veterans

Bohdan was born on the 6th of March 1948 to Wasyl and Stefania Samokyszyn at the displaced person camp in Bad Kreuznach, Germany. In 1949 the Samokyszyn family immigrated to the United States and settled on a farm in Maryland. In 1953 the family moved again and settled in Cleveland's Tremont area.

He attended Our Lady of Mercy School in Tremont, then St. Josaphat School in Parma and graduated from Parma Senior High in 1966. He earned a degree in Business Management from Tri-C College and became a naturalized citizen in 1967.

Bohdan enlisted in the Marine Reserve Program in 1969 and completed boot camp at Parris Island in 1970. Served as Military Police and Completed machine gun training. Bohdan was assigned to the 3rd Battalion, 25th Marines in Cleveland and stayed in the Marine Reserve until 1975. He attended infantry training at Camp Lejuene, desert training at Mojave Desert, beach assault training Norfolk, VA and NATO training in Germany and Denmark. He signed up for another tour 1982-84 and retired as a sergeant.

Bohdan married his wife Joyce in 1977 and they are the parents of sons Ted and Michael and daughter Stephanie.

While working the midnight shift at PPG Industries, Bohdan joined various veteran organizations. He spent 10 years on the National Executive Board of the Ukrainian American Veterans as Historian, Welfare Officer and Vice-Commander. Later he joined American Legion Post 572, and PLAV Roosevelt Post 58 and the Joint Veterans Commission of Cuyahoga County, where is just completing serving as 2nd Vice-President. He has been a delegate to 14 national conventions from UAV Post 24 and PLAV Post 58. Bohdan is serving his 8th term as Commander of the Ukrainian American Veterans Post 24.

Volunteer activities include serving at the Brecksville Medical Center, member of color guard at funerals and parades, helping with fundraisers and volunteers in the placing of flags at cemeteries on Memorial Day.

He is a dedicated veteran and always makes time to help veterans and their causes.

Significant Issues Needing Support

Negative Affect on WWI Memorials (Liberty Row) at Rockefeller Park and Martin Luther King Drive by the Doan Brook Restoration Project [veterans were completely left out of the process] - this issue stems from the transferring of a wetlands project due to the airport expansion to the Liberty Row area. The introduction of wild and unmanaged growth will make the area look abandoned and create a safety issue for visitors, neighbors and volunteers because it will become a haven for wild animals (rabies) and the criminal element. The taking of so much cared for land will remove the opportunity for replanting missing trees that had honored our veterans from throughout Cuyahoga County "Who gave their all" in WWI. There were over 800 plus trees planted with medallions dedicated.

Action Plan A - Circulate existing Petitions for signatures (do not have to live in the city to sign or circulate, this is a county wide issue); call and write letters with petition wording to: Mayor Frank Jackson and Council Members, City of Cleveland, 601 Lakeside Ave., Cleveland, OH 44114. Send a copy to JVCOCC P.O. Box 32700 Cleveland, OH 44132

Action Plan B -For those living outside Cleveland but in Cuyahoga County ask your Mayor & Council for resolutions to stop the Doan Brook Project. Sample city resolutions available by writing to JVCOCC w/self addressed stamped envelope.

Action Plan C - JVCOCC has taken on the responsibility to represent the interests of the WWI Memorials at Rockefeller Park and has organized "Veterans Liberty Row Memorials" (VLRM) and petitioned the Cleveland Cultural Garden Federation (CCGF) to add it as a Cultural Garden member. In conjunction with this action it was requested that the CCGF make changes to its constitution and by-laws to add veterans representing the VLRM and JVCOCC to its executive board so that any activity considered in Rockefeller Park and the Cultural Gardens that can affect the "Veterans Liberty Row Memorials" will be readily known and disseminated throughout the Cuyahoga County Veterans community for review and input.
